Applicable to the Dubai Luxe Allure Escape | September 10–17, 2026

1. Booking & Payments

All funds paid to Simplistic Journeys are **non-refundable and non-transferable** at all times, regardless of reason or circumstance.

A **non-refundable deposit** is required at the time of booking to secure your spot. Deposit amounts vary by promotional tier and are outlined in the official trip guide or invoice.

Final payment for the Dubai Luxe Allure Escape is due no later than February 1, 2026. Failure to pay the full balance by this date may result in cancellation and forfeiture of all funds paid.

Monthly payment plans are available and must be completed on schedule. Missed payments or failure to meet deadlines may result in automatic cancellation without refund.

All **payment processing fees** (e.g., credit card or third-party merchant fees) are the responsibility of the traveler. Simplistic Journeys reserves the right to pass through these fees when applicable.

2. Booking Information & Identification

Reservations must be made through <u>www.simplisticjourneys.com</u>, by calling **1 (888) 383-1273**, or by emailing **info@simplisticjourneys.com**.

Travelers must book using their **exact full name as it appears on their valid passport**. Name discrepancies may result in airline or vendor change fees, which are the responsibility of the traveler.

3. Travel Documents

Travel documents will be released only after **full payment** and a **completed Passenger Agreement** have been received.

E-documents will be sent at least **30 days before departure**. A \$60 fee applies to mailed document requests.

4. Package Inclusions

5. Land-Only Travelers

8. Passport & Entry Requirements
