

Simplistic Journeys General Terms & Conditions
Applicable to All Travel Bookings
Including Bali Escape: Tranquility & Thrills | July 15–26, 2026

1. Booking & Payments

- All funds paid to Simplistic Journeys are non-refundable and non-transferable at all times, regardless of reason or circumstance.
- A non-refundable deposit is required at the time of booking to secure your spot. Deposit amounts vary by promotional tier and are outlined in the official trip guide or invoice.
- Final payment is due no later than March 17, 2026 (120 days before departure for Bali Escape). For other trips, this may vary—refer to your specific trip agreement.
- Monthly payment plans are available and must be completed on schedule. Failure to meet payment deadlines may result in cancellation and forfeiture of funds paid.
- Simplistic Journeys reserves the right to cancel any booking for non-payment, incomplete documentation, or failure to comply with the terms herein. All funds will be forfeited in such cases.

2. Booking Information & Identification

- Reservations must be made through www.simplisticjourneys.com, by calling (813) 733-9570, or by emailing info@simplisticjourneys.com.
- Travelers must book under the exact full name as it appears on their government-issued ID or passport. Any name changes may result in additional vendor or airline-imposed fees.

3. Travel Documents

- Travel documents will be issued after receipt of final payment. E-documents are sent at least 30 days prior to departure.
- A \$60 fee applies for mailed documents. Documents will not be released until the passenger agreement is completed.

4. Package Inclusions

- Land-only packages include accommodations, ground transfers, curated excursions, meals as specified, and Simplistic Journeys enhancements.
- Full packages include all of the above, plus roundtrip international airfare from a designated U.S. gateway.
- Single occupancy includes a private room; double occupancy is based on two travelers sharing a room.

5. Land-Only Travelers (Trip Specific to Bali Escape)

- Land-only bookings for Bali Escape are accepted by request only.
- Travelers must coordinate their flight schedule to arrive and depart within the group's designated timeframe. Any missed transfers or late arrivals are the responsibility of the traveler.

6. Cancellations & Refunds

- All funds are non-refundable and non-transferable at all times.
- All cancellations must be submitted in writing to info@simplisticjourneys.com.
- Refund exceptions will not be granted under any circumstances, including but not limited to personal illness, travel restrictions, work obligations, or changes in personal circumstances.
- Travelers are advised to secure travel insurance that includes "Cancel For Any Reason" (CFAR) coverage if they desire flexibility.

7. Travel Insurance

- Travel insurance is strongly recommended to protect your investment.
- Simplistic Journeys is not responsible for lost baggage, medical emergencies, missed flights, or other disruptions.
- Insurance must be purchased independently by the traveler.

8. Passport & Travel Requirements

- A valid U.S. passport is required for international travel and must be valid for at least 6 months beyond your return date.
- It is the traveler's responsibility to ensure all travel documents, visas, and vaccinations (if required) are current and compliant with destination regulations.

9. Children & Minors

- Children under 18 must be accompanied by an adult.
- For minors traveling with one parent or non-parents, a notarized travel authorization letter is required.

10. Roommate Policy

- Travelers booking double occupancy without a pre-arranged roommate may be paired with another traveler of the same gender.
- If a suitable roommate is not available, the single occupancy rate will apply.

11. Changes & Modifications

- Simplistic Journeys reserves the right to modify the itinerary, accommodations, transportation, or inclusions due to supplier changes, weather, government advisories, or circumstances beyond our control.
- Any such changes will be communicated promptly and will maintain equal or greater value.
- Modifications to the trip do not entitle travelers to refunds or credits unless deemed necessary and approved in writing by Simplistic Journeys.

12. Behavior & Conduct

- Travelers are expected to conduct themselves respectfully and follow all group, local, and international laws and guidelines.
- Disruptive, unlawful, or unsafe behavior may result in removal from the group at the traveler's expense. Simplistic Journeys will not be liable for any additional costs incurred.

13. Limitation of Liability

- Simplistic Journeys, its owners, affiliates, and representatives act only as agents for the traveler with respect to transportation, accommodations, meals, and tour operations.
- We assume no liability for injury, damage, loss, delay, or accident due to any act or default of third-party suppliers or services.
- Travelers agree to hold Simplistic Journeys harmless for any and all losses not directly caused by the agency's gross negligence.

14. Force Majeure

- Simplistic Journeys shall not be liable for any delay, disruption, or cancellation resulting from acts of God, natural disasters, war, terrorism, pandemic, governmental restrictions, labor strikes, civil disturbances, airline schedule changes, or any event beyond our reasonable control.
- In such cases, no refunds will be issued. Travelers must seek recourse through their travel insurance provider.

15. COVID-19 and Health Policy

- Travelers acknowledge the ongoing risk of COVID-19 and agree to hold Simplistic Journeys harmless for any travel disruptions, exposure, or quarantines related to pandemic travel.
- Compliance with all travel advisories, testing requirements, and entry protocols is the responsibility of the traveler.
- Travelers are responsible for ensuring they are physically and medically fit to participate in the planned activities, including long travel days and physical excursions.
- Simplistic Journeys reserves the right to request a physician's clearance for travelers with pre-existing medical conditions.

- All medical expenses, including testing, treatment, or transportation related to illness or injury, are the responsibility of the traveler and should be covered by appropriate travel insurance.

16. Photography & Media Release

- By participating in this trip, you consent to being photographed or recorded during the trip. Simplistic Journeys reserves the right to use such media for promotional and marketing purposes without compensation.
- If you wish to opt out, you must notify us in writing at least 7 days prior to departure. If notice is not provided, media consent is assumed and irrevocable.

17. Health & Accessibility Acknowledgment

- Travelers are responsible for disclosing any medical, mobility, or dietary conditions that may affect their ability to participate in group activities.
- Simplistic Journeys reserves the right to deny participation in any activity that could compromise the safety of the traveler or the group.

18. Passenger Agreement Requirement

- All travelers must complete and sign a Passenger Agreement prior to travel, confirming they have read, understood, and agreed to these Terms & Conditions.
- This agreement includes, but is not limited to, a waiver and release of liability, acknowledgment and assumption of risk, consent to medical treatment, and acceptance of binding arbitration as the sole method of dispute resolution.
- Failure to complete the Passenger Agreement may result in cancellation of the travel reservation without refund.
- Travel documents will only be released upon receipt of a fully executed Passenger Agreement.
- By submitting this agreement, the traveler confirms they are voluntarily participating in the trip and agree not to hold Simplistic Journeys, LLC or its agents, contractors, or affiliates liable for any injury, loss, delay, or damages resulting from participation.

19. Dispute Resolution & Governing Law

- Any dispute arising from or relating to these Terms & Conditions, including claims for breach of contract or negligence, shall be resolved exclusively by binding arbitration under the rules of the American Arbitration Association (AAA).
- The arbitration shall take place in Hillsborough County, Florida, and shall be governed by the substantive laws of the State of Florida.
- By booking a trip, you waive the right to a jury trial and agree to resolve all disputes through arbitration.

20. Assumption of Risk

- Travel involves inherent risks including, but not limited to, accidents, illnesses, political instability, natural disasters, and unpredictable behavior by third parties.
- By booking a trip with Simplistic Journeys, travelers acknowledge these risks and voluntarily assume all such risks associated with their participation in the trip.

21. Severability

- If any provision of these Terms & Conditions is found to be invalid or unenforceable under applicable law, the remaining provisions shall remain in full force and effect.

22. Entire Agreement

- These Terms & Conditions, along with the Passenger Agreement and any written communication confirmed by Simplistic Journeys, constitute the entire agreement between the parties.
- No oral or other written agreements outside of this document shall be binding.

23. Electronic Signatures

- By submitting your Passenger Agreement electronically (via form, booking system, or email acknowledgment), you consent to the use of your electronic signature in lieu of an original signature.
- This consent applies to all transactions related to this booking.

24. Class Action Waiver

- You agree that any arbitration or legal claim shall be conducted on an individual basis and not as part of a class or representative action.
- You hereby waive any right to participate in a class action lawsuit or class-wide arbitration against Simplistic Journeys, LLC.

25. Data Privacy & Communications

- By booking with Simplistic Journeys, you consent to receive transactional and promotional emails, texts, or calls related to your trip.
- We will not sell or share your personal data with third parties without your consent, except as required to deliver travel services.
- You may unsubscribe from marketing communications at any time.
