

# TERMS & CONDITIONS

## 1. Pricing & Availability

All pricing is subject to change until reservation is confirmed in writing. Space is limited and secured on a first-come, first-served basis.

Pricing:

\$1,975 per person – Double Occupancy

\$2,950 per person – Single Occupancy

## 2. Reservation Deposit & Payment Terms

A \$222 per person non-refundable deposit is required to secure your reservation.

All payments are non-refundable and non-transferable.

Final payment is due May 1, 2026 at 4:00 PM EST.

Failure to remain current on payments may result in automatic cancellation without refund.

No refunds will be issued for unused services, late arrivals, early departures, or voluntary changes.

## 3. Refund Policy & Supplier Hierarchy

All services are secured with third-party suppliers.

Any refund is strictly subject to supplier policies.

Simplistic Journeys does not guarantee refunds from third-party vendors.

Improper chargebacks will be contested.

## 4. Occupancy & Rooming

If a roommate cancels, the remaining traveler is responsible for the applicable single occupancy rate.

Room assignments, bedding configurations, and views are requests only and not guaranteed.

Images are representative and may vary.

## 5. Airfare & Travel Documentation

Airfare is not included.

Traveler is responsible for passport validity, visas, entry requirements, and compliance with health regulations.

Failure to comply does not constitute grounds for refund.

## **6. Official Travel Dates**

Valid exclusively for travel June 25–29, 2026.

Airport transfers and Club MoBay services apply only to arrivals June 25 and departures June 29.

Travel outside these dates is at traveler's expense.

## **7. Flight Information Requirement**

Accurate flight details must be submitted by May 11, 2026.

Failure to provide information may result in forfeiture of airport services without refund.

Traveler must notify Simplistic Journeys of flight changes immediately.

## **8. Included Excursion & Activities**

The Island Vibes excursion is included and voluntary.

No refunds or credits will be issued for non-participation.

Activities are operated by independent suppliers.

## **9. Assumption of Risk**

Traveler understands that travel involves inherent risks including delays, illness, weather, crime, supplier changes, and government actions.

Traveler voluntarily assumes all risks associated with participation.

## **10. Medical Responsibility**

Traveler is responsible for personal medical conditions, medications, and fitness for participation.

## **11. Travel Insurance**

Travel insurance is strongly recommended and should be purchased within 14 days of deposit for maximum protection.

## **14. Traveler Conduct**

Simplistic Journeys reserves the right to remove any traveler whose behavior is disruptive, unsafe, or unlawful.  
No refund will be issued for removal due to misconduct.

## **15. Media Release**

Traveler grants permission for use of photos or video captured during the trip for promotional purposes unless written opt-out is submitted prior to departure.

## **16. Limitation of Liability**

Simplistic Journeys acts solely as an independent coordinator.  
Liability is limited to the amount paid directly to Simplistic Journeys.  
Simplistic Journeys is not responsible for injury, delays, supplier changes, government restrictions, or force majeure events.

## **17. Force Majeure**

Simplistic Journeys is not liable for events beyond its control including natural disasters, pandemics, travel bans, or airline disruptions.  
Refunds are subject to supplier policies.

## **18. Indemnification**

Traveler agrees to indemnify and hold harmless Simplistic Journeys from claims arising from participation in this experience.

## **19. Statute of Limitations**

Any claim must be brought within one (1) year from the date of return from travel.

## **20. Mandatory Binding Arbitration**

Any dispute shall be resolved exclusively through binding arbitration in Pasco County, Florida. Traveler waives jury trial and class action participation.

## **21. Governing Law**

This Agreement is governed by the laws of the State of Florida.  
Venue for permitted proceedings shall be Pasco County, Florida.

## **22. Severability**

If any provision is deemed unenforceable, remaining provisions remain in effect.

## **23. Electronic Acceptance**

Submission of payment constitutes electronic acceptance of these Terms & Conditions.
